2. The <u>Roles and Responsibilities of the Anti-Drug and Tobacco Committee</u> (<u>ADTC</u>): The committee shall be responsible for ensuring a drug free and smoke free environment in the CUST and to take measures to safeguard the interests of students in following ways:

- a. by inquiring into, investigating and resolving any matter regarding the usage/consumption, sale and distribution of illegal drugs in CUST;
- b. by inquiring into, investigating and resolving any matter regarding the violation of Anti- Tobacco Legislation at CUST;
- c. by coordinating with and connecting students to rehabilitative services

including counselling, medical care and helplines when needed;

- d. by raising awareness on the prevalence, problems and persistence of drug abuse and tobacco consumption;
- e. by providing advice to CUST administration regarding the implementation of this policy and relevant legislation;
- f. by ensuring effective coordination with all relevant stakeholders inside and outside the CUST;
- g. by maintaining close liaison with hostel wardens for implementation of this policy and may relocate the reasonably suspected student for drug abuse or found addicted;
- h. by taking any other appropriate measures including but not limited to testing of an accused from any authorized laboratory; and
- i. By reporting to the law enforcement agencies if any individual member of the CUST community found guilty of sale/distribution of illegal drugs on campus.

3. Mr. Nauman Shaukat, Assistant Registrar, shall be the Focal Person for matters related to Drug Abuse and un-lawful Tobacco consumption. He will act as a liaison for the members of CUST to ADTC.
