Initially Capital University of Science and Technology (CUST) FOL will offer an undergraduate four-year law degree program. A-Level, Higher Secondary School Certificate, Intermediate, or an equivalent degree is required of those seeking a legal degree. The first degree in law offered by this course, known as the LLB degree, spans 8 semesters. Students who successfully complete the course are granted an LLB degree in compliance with the Pakistan Bar Council (PBC) and Higher Education Commission (HEC) standards.

- (v) Conduct effective legal research using primary and secondary sources and apply critical thinking and analytical skills to interpret laws, identify issues, and develop well-reasoned legal arguments.

■ Admission Requirements

Higher Secondary School Certificate/A-levels (involving 12 years of schooling) or an IBCC equivalent qualification with minimum 45% marks is the eligibility requirement for admission in the LLB Programme. 50% score in LAT test conducted by ETC is mandatory.

■ Degree Requirements

This is a four-year degree program comprising of 8 semesters. There will be a Fall and a Spring semester each year. The maximum duration to complete the Bachelor of Laws program is 6 years. The candidate is required to complete 146 Cr. Hrs. as per following details:
