
- Subsequently, the following agenda items were presented for discussion.

Item # 1 Role and Responsibilities of LSRs

- (a) The LSRs were briefed on their role as the central liaison between the students, the SCALE forum, and the QEC. The importance of maintaining effective communication channels and timely reporting was discussed.
- (b) The responsibilities of LSRs in the Board of Studies (BoS), Board of Faculty (BoF), and Curriculum Review Committee (CRC) were discussed. LSRs were informed that their participation is essential for providing constructive student input, supporting academic quality, and communicating updates on course revisions.
- (c) LSRs were informed about their expected participation in on-site visits during internal and external review panel engagements. This role aims to incorporate student perspectives in quality assurance processes.
- (d) LSRs were encouraged to facilitate meaningful dialogue, collect feedback, and contribute towards academic and personal development initiatives.
- (e) After a detailed discussion, the LSRs acknowledged the outlined roles and responsibilities and agreed to perform their duties accordingly.


- The meeting was then adjourned with a vote of thanks extended to all members present.
